NATIONAL ENVIRONMENTAL POLICY ACT DRAFT ENVIRONMENTAL ASSESSMENT FOR CONVEYANCE OF PARCEL ED-6 TO THE CITY OF OAK RIDGE, TENNESSEE (DOE/EA-1514)

In accordance with DOE NEPA Implementing Procedures, 10 CFR 1021.301 (61 FR 64603, December 6, 1996), DOE is providing affected states, as well as the general public, with the opportunity to review and comment on the EA prior to DOE's final decision on the EA.

DOE representatives will be available to discuss this proposed action. No formal presentation is planned, and you may stop by any time during the meeting.
